WORKSHOP DESCRIPTION

This workshop is designed to challenge and inspire you! The workshop provides an experiential and reflective space for participants to engage in creative processes and conversations to reflect on the artistry of their practice.

Participants will explore in a playful and hands-on way the art of what we do, our identities as mediators, how we think about conflict and its resolution, and where we might like to take our practice in the future.

The workshop will include a range of arts-based activities including improvisation, drawing, storytelling and working with artefacts.

Participants will be asked to do some preparation prior to the workshop, and will be given the opportunity to attend a (free!) follow-up evening 3 months later, to reflect on the impact of their experiences in the workshop on their subsequent practice.

**CATHRYN LLOYD, PRINCIPAL,
MAVERICK MINDS**

Cathryn Lloyd graduated from the Queensland College of Art with a Bachelor of Arts Degree in Graphic Design in 1989. 1990-2001 Cathryn ran her art and design studio, producing commercial and bespoke fabric design and textile products for galleries, government, corporate and private clients. She has tutored and facilitated numerous art and design workshops for arts organisations. She has lectured and designed course material for Southbank Creative Industries Design and Visual Arts department and tutored at the Queensland University of Technology (QUT). In 2001 Cathryn moved to London. At this point her career moved into another creative sphere when she took on the role of Professional Training Manager and Study Abroad Co-ordinator at Central Saint Martins College of Art and Design, University of the Arts London. She worked with a creative group of tutors, designers, and artists developing and delivering arts-based training programs for clients such as BBC, Sony and WPP.

Returning to Australia in 2005 Cathryn turned her interest in arts-based learning into doctoral research by enrolling in the Doctor of Creative Industries at QUT which she is currently undertaking. She is investigating the role of arts-based learning and how artful processes and facilitation can be used in a range of learning environments. Cathryn holds a Certificate IV in Assessment and Workplace Training, a Diploma of Training and Assessment Systems, and a Diploma of Management from the Chartered Management Institute in the UK. In 2006 she established Maverick Minds an arts-based learning and development consultancy. Recently Cathryn presented her paper and model The Sphere of Professional Artistry: the art of knowing what to do when you don't know what to do at the Fourth Art of Management Conference in Banff. Currently Cathryn is collaborating with the Australian Centre for Peace and Conflict Studies to develop arts-based professional development workshops in relation to mediation, conflict resolution and peacebuilding. She continues to devote time to her own arts practice. Cathryn's work, research and arts practice are inextricably linked.



DR SAMANTHA HARDY

Sam is a senior lecturer in Conflict Resolution at the Australian Centre for Peace and Conflict Studies (ACPACS) at the University of Queensland and is the Coordinator of the Postgraduate Conflict Resolution Program. Sam has a legal background and practiced as a lawyer for some years before moving into education and training. She is a Nationally Accredited Mediator and completed advanced negotiation training at Harvard Law School. She is also a CINERGY trained Conflict Coach. She has taught law and conflict resolution for the past twelve years to university students, lawyers and other professionals. She also has a consultancy practice in facilitation, mediation and conflict coaching.

She completed a Masters of Laws in 1997, primarily focusing on Trade Practices Law and Alternative Dispute Resolution. She completed a Graduate Certificate in University Learning and Teaching and her PhD in 2005. She also has a BA (double major in French).

Sam's PhD examined the impact of different methods of dispute resolution on the health outcomes of personal injury litigants. Her research interests include conflict resolution; education; the legal regulation of personal relationships; and the relationships between conflict resolution and psychology, language and literature.

She received a University Teaching Excellence Award in 2003, and a National Carrick Citation for an Outstanding Contribution to Student Learning in 2006. In 2006 she was also appointed a Fellow of the Higher Education Research and Development Society of Australia. Sam is also the Editor-in-Chief of the Legal Education Review, and is a member of the Executive of the Australasian Law Teachers' Association.

Sam is also an experienced researcher and has published widely in the area of law and conflict resolution. She is skilled in both quantitative and qualitative research, as well as reviewing and evaluating organisational and government conflict resolution programs and procedures.



This workshop is part of the research Cathryn is conducting around the field of arts based learning through her Doctorate of Creative Industries. Participants will be invited to contribute to Cathryn's research by providing feedback on the workshop and information about your ideas of reflective practice and professional artistry during and after the workshop.
