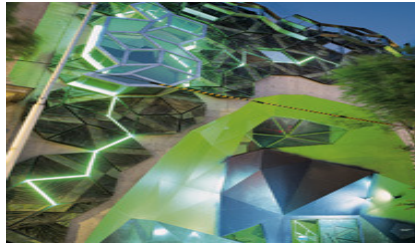




# Restorative Justice Bringing Justice and Community Together
